Thank you for your email. I will champion this project but my challenge is to ensure that we include the appropriate representatives from the Operational side. Ed Hulme will be retiring shortly and his replacement will need to be involved. At this point we do not have a firm date for the replacement. We will also need to involve our civil aviation experts to give us advice on the regulatory perspective.

However, please note that the proponent has been requested on numerous occasions to provide more details of the planned marina development to our Programs Branch for our approval under the Canada Marine Act. Mr. Evans was advised by letter on January 11, 2007 to provide details to Mr. Ed Hulme. This request was again communicated to Mr. Chris Zamora, the proponent's representative by Mr. Cliff Rhodes on Feb. 2, 2007. Mr. Evans also received a letter dated Aug. 1, 2007 from Minister Cannon asking for the proposal so that we can conduct a review.

We hope that this request will be undertaken by the proponent in the near future as any permissions will not be forthcoming until sufficient and adequate details are submitted and have received a thorough review.
